XI. Action Items

A. Second Quarter Budget Report

Motion out of the Finance Committee to accept the Second Quarter Budget Report (6&6) (2022-23) as presented.

Chair of Finance Melissa Baghoumian and Co-Chair of Finance German Wong presented the USU financial summary for the six-month period ending December 31, 2022, where they detailed the period's Revenues and Expenditures. Director Baghoumian and Wong also presented the review of the Statement of Changes in Financial Position, Investment Summary, Unallocated Reserves, Designated Reserves, Capital Outlay, Foundation Account Balances, and Work Study.

B. Alumni Representative Appointment – Joaquin Macias

Chair Olmedo – Torres said Vice Chair Lipton and Acting Associate Executive Director for Equity, Programs & Leadership Tari Hunter interviewed Joaquin and are recommending him for the position.

Macias introduced himself and fielded questions from the board.

C. Year-End Celebration Anonymous Vote

Training & Development Coordinator Christine Aroutounians said that the Year-End Celebration will take place on Friday, May 5, 2023 from 3:30 p.m. – 5:30 p.m. The board is responsible for voting on the Aida C. Salazar Award and the Committee Member of the Year Award.

XIII. Discussion Items

A. 2023-24 Capital Outlay Allocation Proposal

Associate Director for Accounting & Finance Joe Illuminate explained that Capital Outlay, also known as Fixed Assets, is defined as a single item with a value greater than \$5,000 that has a useful life of more than one year and can be used in a productive capacity in the USU. The Capital Outlay Allocation Proposal is separate from the Operating Budget Allocation Proposal. A 10% contingency is added to the base cost of each item in order to allow for potential price increases.


Director Sanchez left at 2:02 p.m. and returned at 2:04 p.m.
