# VII. Vice Chair's Report

Co-Chair Cetz Tamayo mentioned that there is a lot of heavy stuff. We should give ourselves the time to process. Reflecting on the remarks from the event earlier this afternoon, she mentioned that there are a lot of male Black bodies are being lost and being criminalized. She thinks about the immigrant community and those children who have lost their lives.

#### A. Icebreaker/Team Building Activity

# B. Diversity and Inclusion Committee Goals

Chair Benkovic reviewed the previous academic year's goals: researching other student unions, visiting the centers in the USU, and reviewing policy. Current academic year goals will include supporting the cross cultural center initiative, supporting undocumented students with employment, speaking with our constituents and centers and see how we can support them. Gender inclusive restroom in the USU will be a two-stall restroom with construction to begin over the Winter break. Dream Center expansion has been completed.

J. Herrington recommended that we push for a grant for ASL interpreters to be provided for activities within the USU (non-academic activities) or an in-house interpreter.

Co-Chair Cetz Tamayo asked the committee to consider what other things are lacking.

D. Joves recommended making all the restrooms in the USU gender inclusive.

M. Alvarez Rojas recommends that we consider safer locations for gender inclusive restrooms.

- F. Sanchez introduced the topic of lactation spaces, which may come up through Facilities Committee.
- M. Alvarez Rojas recommends informing students at-large of opportunities for priority registration.
- D. Joves inquired regarding legal assistance for students. Co-Chair Cetz Tamayo commented on the current offerings via Associated Students.
- S. Barboza recommended adding formerly incarcerated students to the BOD goal for assisting undocumented students with employment in the USU, while working with Revolutionary Scholars.
- D. Joves inquired regarding whether the public can access services in the USU.
- K. de Leon inquired if there is a question that students have to answer regarding their status if they were formerly incarcerated and if there were job opportunities.
- S. Barboza inquired regarding the VITA Clinic and whether we can provide a legal clinic accessible to the entire community here in the USU. Co-Chair Cetz Tamayo clarified that VITA is a national program receiving funding through the Nazarian College.
- D. Joves inquired regarding the use of student union spaces and making events accessible to the students through a usage policy.
- Co-Chair Cetz Tamayo recommended we look into access to research for undocumented or formerly incarcerated folx, and any others who have been neglected.
- K. de Leon recommended the Pride Center provide opportunities for research (e.g. research symposium). Chair Benkovic expanded to include the Veterans Resource Center.
- J. Herrington suggested conducting a needs assessment survey to find more information regarding demographics of the populations served by the USU.

Respond to the email regarding the USU survey.

- Co-Chair Cetz Tamayo recommended the USU look into ways to better serve the homeless student population. K. de Leon recommended the Oasis remain open late for students to sleep (e.g. close to midnight).
- M. Alvarez Rojas recommended more affordable food options, housing for low-income or homeless student population.
- D. Joves recommended extending the CSUN Food Pantry beyond their current hours. Pop-up Pantry was made possible through a \$10,000 donation from the USU.
- J. Herrington recommended the USU provide a space for commuters.
